



Digital Licensing Made Easy

Your institution or school has a comprehensive **Print** photocopying licence through Access Copyright, The Canadian Copyright Licensing Agency. This licence covers photocopying of print materials only and does not authorize any digital uses of material (e.g. posting to an intranet, emailing, or scanning). If you wish to copy copyright protected material from digital to print, print to digital or digital to digital, you must obtain prior permission. To do this, you may request a separate **Digital Pay-Per-Use (Transactional) Licence** from Access Copyright or seek permission directly from the copyright owner or owners.

How do I obtain a Digital Pay-Per-Use Licence?

You can obtain a Digital Pay-Per-Use Licence by emailing your request to permissions@accesscopyright.ca. When emailing our permissions department, please include as much bibliographic information as possible on the work you wish to use digitally. As well, you can use our Rights Management System (RMS) located on our website (www.accesscopyright.ca). A PDF version of our RMS User's Guide is also posted on our website for your reference. Alternatively, you may contact the copyright owner or owners directly to seek permission.

How long does it take to obtain a Digital Pay-Per-Use licence?

If you are requesting permission from permissions@accesscopyright.ca, please allow three to five business days for your request to be processed. During our peak times in summer and late fall (November and December), please allow seven to 10 business days. If you are requesting permission through RMS, the licence will automatically be granted if digital permissions have already been given to Access Copyright (if this is the case, there will be a CD icon beside the work on RMS).

How much does a Digital Pay-Per-Use Licence cost?

Digital royalties are based on a per-page, per-user basis, which are set by individual copyright owners and vary according to the exact works used. If a royalty rate has not been set by the copyright owner or owners, then Access Copyright's default rate is \$0.15 per-page, per-user, per-course session for intranet use.

What are the terms of use for the Digital Pay-Per-Use Licence?

The default term of use of the Digital Pay-Per-Use Licence is the length of the course session for which the licence is obtained, up to a maximum of 12 months. For example, if a course runs from September to December and a Digital Pay-Per-Use Licence has been purchased for the use of a copyright protected article to be posted to an intranet site, it would have to be repurchased if that same article is to be used for the next semester by a new set of students starting in January.



May I provide my students with paper copies of material found on digital sources (e.g. subscriptions or the Internet)?

You must check the terms of use found on the website or subscription agreement related to the material you wish to copy. These terms may permit or prohibit the use you want to make. If there is still uncertainty, you may wish to contact your legal counsel.

If the terms of use of the digital source permit you to print one copy, your Access Copyright licence may permit you to make multiple copies for your class or for post-secondary institutions, to include it in a coursepack. In this situation, you must determine if:

- the material you wish to use also exists in print form (e.g. an article from the Toronto Star or an academic journal such as Nature) and
- the print source would be covered by your Access Copyright licence.

If the answer to both questions is yes, then the paper copy you are permitted to make from the digital source is considered a legally obtained paper copy under your licence with Access Copyright. It may therefore be copied in accordance with the terms and conditions of your licence.

Are materials found on the Internet part of the public domain?

No, Internet materials are not necessarily part of the public domain. While materials are posted on the web for free viewing, it does not mean that free copying and reposting of these materials is permitted. You must check the terms of use found on the website or subscription agreement of the material you wish to use. These terms may permit or prohibit the use you want to make.
