 - i. Halloween party

Kyle Bobiwash (chair) would like to start a BC Wildlife Society Student Chapter. The Wildlife Society is an organization focusing on conservation and wildlife management. iii. Update from GSS Caucus Training - caucus credit card

Heather Coatsworth (Associate Chair) attended the GSS Caucus Training. She proposes to get a caucus pre-paid credit card for the next fiscal year (September 2017), so the Events Committee and other members can easily pay for caucus costs without going through the GSS reimbursement process.

iv. Sponsoring the PPMABC

The Professional Pest Management Association of British Columbia is having their general meeting on the SFU Burnaby campus in March 2017. This conference is especially useful for MPM program students or M. Sc. And Ph. D. students who are working on pest management projects. The organizers request sponsorship from the BISC graduate caucus.

Caucus members discussed how much money to offer to this event, and the decision was made to spend \$10 per person, so if 10 caucus members are expected to attend a meeting, \$100 will be offered.

New Rule of thumb for conference funding:

If 10 people go \rightarrow \$100 caucus funding

If 20 people go→ \$200 caucus funding

v. Sponsoring IDEAS

The Earth2Oceans Group and the Fisheries Group from the School of Resource Management (REM) are organizing their yearly conference IDEAS. This full day conference focuses on Aquatic Ecology and is attended by 30-35 students. It takes place on January 28th 2016.

The caucus would like to sponsor this event only if registration will be opened up for students outside E2O and REM, who also study Aquatic Ecology. Dan Greenberg will look into this. However, this conference is meant to stay small and informal, so it offers a safe environment for practicing talks and presenting preliminary results.

3. Committee updates

A. DGSC – Dan Greenberg and Kevin Hegeman

- The Biological Sciences Department succeeded to still let BISC800 (Skills for the Successful Scientists) and seminar courses count as credit courses (satisfactory/unsatisfactory courses generally do not receive credit).
- Some changes to courses took place:
 - o BISC 829 (Conservation Ecology) no longer exists because it is redundant
 - BISC 821 is going to be a conglomeration of 821, 822, and 823 (seminar courses). You can now take BISC 821 three times instead of adding more course descriptions.
 - o BISC 891 is added: the Ph. D. Candidacy Exam. This will be an 'in progress/complete' type of course that opens up possibilities like giving feedback on how you are doing.
- The Senate passed regulations for new students. The maximum number of terms will be 12 (4 years) for M. Sc. students and 18 (6 years) for Ph. D. students. After that you need to request extension (maximum 18 terms for M. Sc. students and 24 terms for Ph. D. students).
- The BISC caucus held an ad hoc meeting on October 19th 2016 about student-

supervisor relationships. The results of this meeting were brought to the DGSC meeting.

Proposed ideas by the caucus members:

- 1. Creating an expectation guideline for students to go through with their supervisors
- 2. Amending the Annual Progress Report (APR) to add a section to the Milestones: what are supervisors going to do to meet these milestones? The main objective of this is to prevent future conflict.
- 3. Department-wide anonymous survey for graduate students to rate their supervisor. The objective is to identify problem areas. The results would not go to the supervisor.
- 4. Exit interviews for alumni that would take place a certain time after graduation, to identify worry signs.

The DGSC members said that the guidelines (1) already exist, but it is in the format of 'what to expect from..'. It is currently not required for supervisors to go through the list. The DGSC is not in favour to making this mandatory, but they want to encourage and stress supervisors to go over the guidelines with their students. Apparently the Department of Graduate Studies already conveys exit surveys (4). The DGSC would like to work with us to push the guidelines document (1) and amend the APR (2).

- If you have specific ideas about amendments of the APR, contact Dan Greenberg (dgreenbe@sfu.ca) or Kevin Hegeman (khegeman@sfu.ca). They also invite you to discuss your current student/supervisor problems with them so they can bring your issues anonymously to the DGSC.
- Members argue that these solutions still do not hold supervisors accountable.
 However, these solutions are to prevent escalation, and to make supervisors more coresponsible for the milestones of their students.
- The guidelines will be given to new students, not to current ones.
- Margo Moore (DGSC chair) will be invited to give advice and hold an open dialog to student/supervisor relationships in the next caucus meeting.

B. DSC – Pauline Deschodt and Jenny Bigman

The committee has created a standardized yearly timeline to show which scholarships will be available, and when the application period starts and ends. This overview has been spread by email and posted on the BISC Graduate Caucus website. There still is a Biology Private Award open for application (related to Pest Management).

C. GSS – Allannah Biega, Leon Li, Mike Hrabar

SFU is working on adopting a Sexual Violence and Misconduct Policy. Everyone is invited to contribute their thoughts to the drop-in events.
