- Caucus had general discussion and loose vote to see what topics should be kept in BISC 800, and what could serve as workshops.
- Main conclusions:

Writing grants and scholarships: workshop

Mental health + imposter syndrome: workshop AND BISC 800 Post degree-career options: workshop or BISC 800 panel discussion

Time management and different working styles: BISC 800

Online presence: BISC 800

Ethics: animal care, euthanasia, academic honesty, research fraud, etc: BISC 800

Posters: BISC 800, but not a priority

Writing results: BISC 800, but not a priority

BISC 800 topics: The BISC 800 instructor should to be able to teach the content or invite

someone in who is a better expert on the topic.

Degree requirements:

-BISC Graduate website pages are difficult to navigate and there is contradictory information on several links. Melissa went through calendar and biology website, copied into all same word document. A lot of conflicting information and information stored under the wrong headings. Arne Moore offered to format it into one PDF document. However, this would require an update on an annual basis. Website will need to be fixed no matter what, so it would be excellent to get that under weigh.

-Melissa will meet with Jenny Cory and see how it can be fixed, or Melissa could be compensated to fix the website pages herself. Someone should be dedicated to updating the website.

Colin B: Special Departmental meeting, took place on March 25.

- Unanimous support to hire Dr. Moorecroft for a tenure hire. Hiring him does not take away from the hiring needs of the department.
- Key request has been transferred to Laurie (from Maya).
- Budget is going from \$200 to \$300 for Wednesday Illia post-seminars
- News from Deans Advisory Cmmittee meeting: New committee to manage graduate student enrollment at the university level. New cap on how many new grad students will be admitted on a university wide scale. Within Biology and Science in general, there's a high demand for TAs, so graduate students are very much required for this reason alone. Resist fewer grad students being admitted.
- New advancement director.
- Retires will create gaps in the departments (Felix Braden August 2019, Malo Fernando April 2020, Joan Sharpe August 2020).
- 5 priorities for the hiring plan by the department:
- 1. Environmental Microbiology, with expertise in ecotoxicology
- 2. Lecturer in plant biology + physiology (teaching plant physiology, algae and fungi)
- 3. Lecturer in BISC to replace Joan Sharpe to teach BIC 102 and 106
- 4. Cell biology and physiology tenure track position
- 5. Evolutionary biology tenure track position

Looks like there will be a movement to try and real back all the new departments coming up and make everything more cohesive.

- 5 Canada Research Chairs, each chair is a hiring opportunity. Statistics department is interested in obtaining a CRC. Potential cross over between a statistics hire and an applied biology statistics expert for higher level complicated statistics. Could also apply to other disciplines like psychology. Current CRCs (outside priorities, though they could be aligned with department hires, as it is easier to fill a CRC position):
 - Stem Cell Biology (Neurobiology)
 - Data Science (Dept of Statistics)
