## iii) Gauging interest in a BISC Biorender account (Pauline Deschodt)

- <u>BioRender</u> is an application used for producing publication-quality scientific figures.
- Representatives of BioRender reached out to Danielle and Pauline from the Cory lab regarding potential interest in setting up a department-wide Biorender account.
- A BISC BioRender account could be tied with product provisions already provided by the university (rather than covered by additional graduate fees).
- Next steps:
  - BioRender reps are interested in holding an information webinar where they
    would also give out free trial subscriptions. Brett or Pauline will send out a
    survey/poll for a prospective date to host the webinar for interested students
    and staff.
  - Brett will bring it up at the upcoming departmental meeting.
  - Further steps need to be taken to obtain a price quote.

### iv) Following up on BISC Slack group (Ramis Rafay)

- Ramis has looked over details concerning the old slack group. Rather than reaching out to long-graduated past admins, it seems easier to simply form a new slack group.
- We are now looking for admins for channels within the group.
- Hannah suggests that maintenance of the BISC Slack group could fall under webmaster duties.

# 2. Representative updates

#### DGSC (Steven Brownlee)

- Wendy Palen runs her population modeling course as a condensed 4-week course.
- Mike was curious to know whether grads were interested in more condensed courses (either condensing current courses or adding new courses that are in a condensed format). Condensed courses can make things easier for instructors, presumably allowing for more graduate courses being offered (and more frequently).
- From the meeting: the current general consensus in the caucus is that people are open
  to the option for more condensed courses being added. Overall preference for or
  against a condensed course format seems quite variable student-to-student.

## DSC (Em Lim)

- The DSC is ranking NSERC-CGSM applications. This time around there is an 8 student quota.
- The DSC has finished ranking president's PhD scholarship applications.

## GSS (Steven Brownlee)

- The previous meeting saw some small bylaw changes and a finance update.
- The GSS is doing well financially, having received a \$40k donation to the Emergency Grocery Card Program (see December 8<sup>th</sup> meeting minutes). The GSS is waiting to learn whether this donation will be recurring before continuing with further financial planning— either making additional grocery cards available or diverting money from the card program to other initiatives.
- **Professional development grants** (\$500) to go to conferences are now back the GSS had previously shifted away from providing these grants due to COVID.

### TSSU (Steven Brownlee)

- **Bargaining** for TAs has now also started up. Previously the SFU bargaining team was incapable of working on both RA and TA bargaining.
- **RA bargaining** is stalled as usual nothing new to update on this matter.
- If you are not from BC and are paying an **international health fee**, the TSSU can help you get health coverage! Please feel free to email the TSSU to get help to navigate getting your money back. Note: You can also do this retroactively!

# 3. Committee updates

- i) Events (Brett Hodinka General group discussion)
  - A highly successful BISC Graduate Symposium was held previously, however, additional symposia were not organized due to COVID. The Grad Symposium served as a way for labs to introduce themselves to the BISC community in a fun way via a no-pressure show

- where grad students (either individually or in groups) gave 3-5 minute talks explaining their lab's work in a show-and-tell style.
- The past symposium received lots of support from faculty and the department and, if brought back, could serve as a fun Spring event in alignment with Tony's directive for boosting departmental collegiality.
- Organization of the event would involve booking a room, organizing food and drinks, and forming a schedule of talks (sign-up form).
- Brett will bring this prospective event up at the upcoming faculty meeting and gauge graduate and staff interest in giving talks.
