Highlights of Activities Completed

This year, SCUTL provided advice and feedback to a variety of individuals and groups in addition to performing specific committee functions. These are listed below:

1. Provided feedback and recommendations on the Teaching and Course Evaluation Project (TCEP) Final Report to Senate.

The goal of the Teaching and Course Evaluation (TCE) project was to make recommendations to govern the selection/development of an updated system for student evaluation of teaching and courses that reflects new understanding from educational research and is more focused on student learning. In particular, the goal was to recommend key requirements for the replacement of the existing instrument and processes with an emphasis on:

- Improving the teaching and learning environment
- Ensuring efficient methods of data collection, storage and protection of privacy
- Adopting guidelines for best practices in the use of evaluation data.

The project was based on earlier work by the Senate Committee on University Teaching and Learning (SCUTL) and the Task Force on Teaching and Learning (TFTL). The project utilized a pragmatic approach starting with a literature review in support of the goals of the project and consultation with other institutions. The heart of the approach was a strong focus on engaging with the SFU community. Lastly, a proof of concept was completed as a small scale practical application of the recommendations that had emerged. The final report on the project was approved by SCUTL on November 25, 2013, and sent to Senate where it was approved unanimously on January 6, 2014.

2. Provided feedback to Jon Driver and Bill Krane on the Task Force on Flexible Education (TFE). The committee provided feedback and comments on the composition of the Task Force, the definition and scope of Flexible Education, and the need for institutional support for instructors pioneering innovative approaches.
3. Elected a new Chair.
4. Reviewed Terms of Reference.

Activities to be Undertaken in the Coming Year (2014-15)

1. Compile effective practices and principles for evaluating teaching at SFU.
 - With the anticipated implementation of online software and the new teaching and course evaluation form over the next academic year, SCUTL will lead a project to determine principles and examples of effective practices. These resources may then be used by departments as they consider evaluating teaching more broadly and beyond the Teaching and Course Evaluation form. The project will entail collaboration between SCUTL, academic and administrative units.
2. Active participation and input into the Task Force on Flexible Education's activities.
 - The Task Force's work is anticipated to have a broad impact on teaching and learning at SFU by identifying priorities and strategic directions related to enhancing the SFU students' experience. SCUTL participation may include aiding the environmental scan, providing input on priorities, engaging in working groups, and contributing to the final recommendations and implementation plan.
3. Involvement in STLHE planning, promotion and conference participation.
 - SCUTL members will be involved in the STLHE (Society in Teaching and Learning in Higher Education) 2015 national conference by serving on subcommittees, promoting the event, and encouraging SFU faculty and instructors to share their expertise and experiences. The conference is being co-hosted by SFU and UBC. Contributions to this conference would showcase SFU's talent and also enable networking and professional development with other faculty and instructors from across the nation.
4. Elect a new Chair.
5. Revise the Terms of Reference.

7. To consider such matters, related to teaching and learning, referred to the Committee by Senate and its committees.
