3. 2021 Study Abroad Program Statistics – Overall Summary (Appendix A)

Enclosed is the 2020/21 Study Abroad Programs report for programs administered by International Services for Students (ISS).

Impact of COVID-19: The COVID-19 pandemic had a severe impact on study abroad programs around the globe which resulted in the cancellation of all SFU's in-person inbound and outbound international exchanges, study abroad programs and field schools during the 2020/21 year. Long planning horizons for study abroad programs allow us to identify the projected activity and impact. 2020/21 was projected to be the highest level of activity for ISS programs to date, with 565 students selected for outbound programs.

On March 13, 2020, Global Affairs Canada implemented a global travel advisory to avoid non-essential travel (Level 3), which resulted in the cancellation of most university-related student international travel, as per SFU's interim university-related international travel policy. This advisory was in place throughout the entire 2020/21 year and beyond, resulting in the cancellation of all outbound in-person SFU student mobility programs. The Canadian government implemented a series of travel and entry restrictions which prevented most exchange students from entering the country during this period. SFU was also teaching primarily through remote instruction during these terms.

Outbound Exchange: In January 2020, application numbers had increased nearly 20% over the previous year. ISS nominated 384 students to go on exchange during the 2020/21 year.

Field Schools: SFU was planning to send 10 international field schools in Summer 2020, with a total of 181 students. This would have been a program increase of 3 more than in 2019, with a participant increase of nearly 75% over the previous year. All of these programs were cancelled, though one program ran their field school virtually that Summer. (ISS supported several programs to transition to virtual delivery for Summer 2021 – this will be included in the 2021/22 report.)

Inbound Exchange: SFU was planning to receive 266 inbound exchange students during the 2020/21 year.

The near-global shift to remote learning created an opportunity for innovation in global education. SFU leveraged this opportunity and developed a number of virtual global learning pilots, including virtual exchange programs and field schools. This activity will be summarized in a new report on Virtual Mobility.

Student interest in study abroad programs has remained strong and demand for in-person programs for 2022/23 has nearly returned to the record high levels noted above, as of the date of this writing (March 2022).

Report A provides an overview of activity through the Formal Exchange Program and other study abroad programs. This report includes face-to-face physical mobility only, and thus reflects near-0 activity for the 21/22 year.

Report B is a new report outlining participation in virtual mobility.

 $Due \ to \ COVID-19, no \ physical \ mobility \ was \ possible \ for \ the \ full \ duration \ of \ the \ 2020/21 \ year \ for \ the \ following \ reasons:$

- Outbound: Global Affairs Canada maintained a Level 3 global travel advisory which invoked SFU's interim university-related international travel policy and did not allow for student travel.
- Inbound: Canada implemented border and travel restrictions that did not allow exchange students to enter the country. SFU was also instructing primarily remotely during these terms. The student in the above statistics was a participant in the Formation Duale program with EDUC/OFFA, who had been studying at SFU since Spring 2020. Some virtual activity took place during these semesters, outlined in Report B Virtual Mobility.

Inbound Study Abroad refers to inbound students who attend SFU for 1 to 3 terms under the terms of a formal agreement with another institution. Students pay international, or in special cirumstances domestic, tuition rates.

Outbound Study Abroad refers to SFU who students who attend a partner institution for 1 to 3 terms under the terms of a formal agreement with another institution. Students pay tuition fees directly to their host institution.

* Years 1992/93 - 2009/10 were reported by Academic Year (Fall, Spring, Summer). The Fall 2010 term was reported separately. Years 2011 to 2017 were reported by Calendar Year (Spring, Summer Fall). Years 2017/18 to present were reported by Fiscal Year (Summer, Fall, Spring) which coincides with the Exchange Program Year. As a result, the Summer 2017 and Fall 2017 terms are reported in both the 2017 Calendar Year stats and the 2017/18 Fiscal Year stats. Beginning in the 2015 calendar year, numbers are reported in terms of both unique student counts or term counts. Prior to 2015, annual numbers were reported only in one of these ways.

**Between 2006/07 - 2011, study abroad students were in some cases admitted at the domestic tuition rate instead of international. This practice was discontinued after 2011.

SCIA Report B: Virtual Mobility 2020/21

The near-global shift to remote learning in 2020 created an opportunity for innovation in global education. SFU leveraged this opportunity and developed a number of virtual global learning pilots, coordinated through a Virtual Global Learning Working Group. ISS's virtual mobility activity is summarized in this new report.

Virtual exchanges use existing mechanisms and partnerships for reciprocal exchanges which enable students to attend online courses at a partner university, full-time or part-time. ISS developed a regularized outbound <u>Virtual Exchange Program</u> which was launched for 2021/22. The considerations and next steps for ISS virtual mobility programs will be addressed in the 2021/22 report.

Virtual Exchange - Outbound

Outbound Virtual Exchange activity in 2020/21 took place as an alternative for students who had originally sought in-person activity.

Summer 2020: Some of SFU's partner institutions quickly transitioned their Summer 2020 programs to virtual delivery. 2 SFU students were able to participate.

Fall 2020: Following the cancellation of in-person study abroad programs, 2 students ultimately decided to participate in a virtual exchange as an alternative.

Spring 2021: By this term, more of SFU's partners had developed virtual programs. Following the cancellation of in person study abroad programs, 8 students ultimately decided to participate in a virtual exchange as an alternative.

Virtual Exchange – Inbound

Fall 2020: Beedie School of Business hosted a small pilot inbound exchange program of 5 students. All students studied full-time in this pilot.

Spring 2021: Following consultation with academic units, ISS expanded the Beedie pilot university-wide, and hosted 27 virtual exchange students at SFU. Of the group, 24 studied full-time, and 3 studied part-time, allowing them to combine SFU courses with home university courses if desired. Students had access to remotely-delivered courses across most disciplines, subject to restrictions and limitation. Modified virtual programming and support was in place to support the student experience. Given the reciprocal nature of students mobility agreements, ISS managed the balances, as usual.
