OLD BUSINESS

3. Orientation

6. Buddy Program

After some discussion it was agreed that we have two different orientations for international students who need more one-on-one help, and for other graduate students. Marela¹s idea for having one or two experienced students from each program was accepted as a workable plan for all grad students. We need to identify people who are willing to be the contacts for each program area. Isabelle expressed interest in this for the ed. tech. specialisation.

For international students, Randa Mahasneh had volunteered to be the liaison, and we have also had offers from Amrit Mundy. We should perhaps think about having a small team (2-3) to avoid burnout and isolation? A suggestion was made to introduce this at the special orientation/meeting for international students being organized by Grad Progams.

7. Symposium

Brief updates on the planning of the symposium were given by committee members present. As there were only 28 registrants so far, it was agreed that by far, promotion was the most important action item at this point. Those present divided up the classes for the week to take care of announcements and promos in those classes.

8. Finances

9. Hartley

Grads present thought this was a very good idea. Who would be responsible for the printing etc, and what would the process be?
