## **Additions via E-mail Communications**

In an email communication within the Caucus on January 30<sup>th</sup>, 2012, Reagan Belan motioned for the purchase of 1 nut brown ale keg from Howe Sound Brewery, which will be delivered to the SFU campus free of charge. This purchase will take place on February 1<sup>st</sup>, 2012.

- *Motion carried (for the purchase of the nut brown ale keg).*

In an email communication within the Caucus on January 31<sup>st</sup>, 2012, Reagan Belan informed the Caucus that the DGS has misinformed the Caucus re: tuition relief. Please see below for an excerpt from the GSS email that was forwarded by Reagan to the Caucus:

Mary Ann Pope, the Director - Graduate Admissions and Records in the DGS, informed us that the 6 terms one accumulates during a Masters DOES transfer to the PhD, meaning, a student would get the PhD reduction after only another 2 terms (the PhD minimum is 8 terms, the MA is 6). If a student is in the 7th term of their MA and then they transfer to a PhD for their 8th term, they would have paid the reduced fee in the 7th term and then they would pay the full PhD fee for the 8th term, but they will go back down to the reduced PhD fee for the 9th+ terms. She said this is all done automatically in the system.

Given this information, it would be great if you can see if students who are in their 9+ term (since beginning an MA) are being charged full tuition. If so, please direct them to Christina who can help them to get in contact with Mary Ann Pope.
