Report of the Committee on Scholarships, Awards,
and Bursaries

- I. A Committee to deal with Scholarships, Awards, and Bursaries was established initially by the President in September 1965, with the following membership: Professor T. B. Bottomore (Chairman), Dr. G. Kirchner and Dr. A. M. Unrau. This Committee was responsible for awarding scholarships, for making awards for athletics and for other contributions to University life (in the Student Council, the theatre, the student newspaper), and for granting bursaries in the Fall Semester 1965 and the Spring Semester 1966.

Following the constitution of Senate a permanent committee was established by Senate at its meeting of April 4, 1966. The membership of this Committee is: Professor T. B. Bottomore (Chairman), Dr. F. F. Cunningham, Dr. G. Kirchner, Dr. R. G. Korteling, Dr. T. J. Mallinson, Dr. A. M. Unrau, and Mr. B. J. Penny (Secretary). At the same time two other committees were established by the President, one under the chairmanship of Dr. Kirchner, to advise on Athletic Awards, the other, under the chairmanship of Dr. Mallinson, to advise on University Awards. These committees make their recommendations directly to the President, but their proposals are also reviewed and approved by the Committee on Scholarships, Awards, and Bursaries.

- II. The Committee held its first meeting on April 18, 1966, and since that time it has met regularly at the beginning of each semester to make the various awards, and on at least one other occasion during each semester to review the awards and to discuss general matters of policy.

The appendices of the present report provide information on the scholarships, awards, and bursaries granted in each semester since September 1965.

- III. At one of its meetings during the Summer Semester, the Committee is required to prepare a budget for the next financial year and to propose an allocation of funds between the three semesters. Our proposals for 1967-68, which were presented for incorporation in the University budget, as follows:

From this total sum there should be deducted the funds made available privately for awards and bursaries, and the Committee considers that these will probably amount to \$40,000. in the year 1967-68. The University does not provide any scholarships from its own funds, and consequently these are not included in the budget. Scholarships from private sources will probably amount to some \$5,000. in the year 1967-68.

IV. The Committee has also been concerned to establish formal procedures for making the different awards. Bursary applications now go directly to Mr. Penny, the Financial Aid Officer; a provisional list of bursaries is approved by the Committee before registration takes place at the beginning of each semester; and students are informed of the probable amount of their bursaries during registration. Subsequently, the bursary list is reviewed in the light of student requests for additional aid and of funds available, and it is then finally approved. The procedure has worked well in the last two semesters and we are pleased to be able to report that the Financial Aid Officer was congratulated in the student newspaper for the manner in which bursaries are handled.

Athletic Awards and University Awards are determined by the two President's Committees referred to earlier, upon recommendations made by individuals who have observed the student's contribution to University life, or in the case of a student entering for the first time, his contribution in high school or in his community.

Scholarships have been awarded by the Committee on the basis of semester grades and reports from the student's teachers. However, we consider that the procedures here need to be improved, in order to provide more public competition for scholarships. We propose that in future, therefore, students should present themselves as candidates for scholarships during the first week of each semester, on the basis of their grades in the previous semester which they attended, and that the candidates should then be considered by a committee in the discipline or Faculty to which each scholarship relates, with an interview as part of the procedure where necessary. These committees would then make recommendations to our Committee. This practice has already been followed in some cases, and we think that it should become general.

V. During the past year the Committee has discussed a number of policy questions.

It was evident that the sum of money available for bursaries in 1966-67 did not fully meet the needs, and the Committee has proposed an increase for the next financial year. During the current year some alleviation of the situation has resulted from our being able to devote to bursaries, surpluses from the Athletic Awards and University Awards funds, but such surpluses are not likely to occur in future.

It is also evident that the University is very poorly endowed with scholarships for undergraduate and graduate students. The Committee has discussed this matter on several occasions, but we consider that it could best be tackled by the University as a whole, and that a public appeal for scholarships might be envisaged.
