Our Graduate Studies Committee, meeting on November 4th, has proposed three more Graduate courses in English which will require change in the Graduate Calendar, page 68, by insertion of the following entries between the present entry "813-5 Special Studies" and the present entry "898 M.A. Thesis".

- 841-5 Directed Studies
- 842-5 Directed Reading
- 843-5 Directed Research

I believe the addition of these three courses will require approval of Arts and Senate because they involve new course numbers and new course descriptions. They nevertheless do not purpose any major change in the department's teaching practices. The department does now from time to time offer scheduled courses on various subjects under the number and description "English 813-5 Special Studies" and does now also every semester give numerous unscheduled individually supervised directed reading courses which we cannot now show anywhere except under the same number and description, "English 813-5 Special Studies".

The addition of the new numbers and descriptions, to be used exclusively for the unscheduled courses, will facilitate computer processing, avoid apparent duplications on transcripts, and make all our statistical records more meaningful. Their addition will not require any increase in our faculty.
