Extends creativity and problem solving to the realm of the human body and studies its possibilities as an expressive instrument. It is different from Kines 044 - Aesthetic Forms of Human Movement inasmuch as Kins. 044 - is an exploratory course whereas Kines 344 utilizes the knowledges and skills gained to create individually and in groups.
