Subject ELECTION OF A STUDENT SENATOR

Date JUNE 20, 1973

MOTION: "That Senate suspend the rules that interfere with consideration of postponement of an election for student senator and the seating of an interim student senator."

MOTION: "That the call for an election of a student senator to replace P. M. Doherty be postponed until September, 1973, with the election to be completed by October 31, 1973; and that Mark Haynes be seated as interim student senator until October 31, 1973."

Subject Election of a Student Senator

MOTION: "That Senate suspend the rules that interfere with consideration of postponement of an election for student senator and the seating of an interim student senator."

Background:

The resignation of P.M. Doherty necessitates an election for a replacement for the remainder of his term until May 31, 1975. Normally these elections are held as soon as possible; in this instance it would be held during the summer semester.

SUBJECT: Election of a Student Senator

DATE: June 21, 1973

That the call for an election of a Student Senator to replace P.M. Doherty be postponed until September, 1973, with the election to be completed by October 31, 1973; and that Mark Haynes be seated as interim Student Senator until October 31, 1973.

Rationale:

This motion allows immediate representation from students and an election would be held in a period when the majority of students can participate in this important process.

In a discussion at the Student Society Executive Council meeting of June 14, 1973, the following motion was passed:

Moved that: The Student Society requests the S.F.U. Senate to delay the call for the election of a Student Senator to replace P.M. Doherty until September, the election to be completed by October 31, 1973. Further, that Senate suspend the rules regarding the election of Student Senators and allow the Student Society to appoint its President-elect, Mark Haynes, to serve as an interim Student Senator until that election is completed.

The S.F.S.S. Executive Council felt that Mr. Haynes would be a logical choice for an interim appointment since:

- he was elected in the Spring semester when there was a high student enrolment;
- since Mr. Haynes is not presently on Council he can be said to represent the student body as a whole rather than the interests of the present Council;
- Mr Haynes meets all present criteria to be a Student Senator.

5. Formally registered this semester
6. Now carrying 16 semester hours for credit
