CHANGE IN TITLE AND DESCRIPTION

FROM: FREN 341-3 French Literature in Translation II

An alternate course to FREN 340-3. For course description see FREN 340-3 above. Knowledge of French is not required. (This course does NOT count towards the degree requirements for a minor, major or honors in French.)

(Lecture/Tutorial)

TO: FREN 341-3 FRENCH CANADIAN LITERATURE IN TRANSLATION

A survey of significant authors and themes of French-Canadian literature to be selected from various periods and genres, usually with emphasis on the development of the novel. Also an introduction to the relationship between French-Canadian literature and its socio-cultural context).

(Lecture/Tutorial)

Knowledge of French is not required. This course does NOT count towards the degree requirements for a minor, major or honors in French.

RATIONALE: Each time FREN 341-3 has been offered, it has dealt with French-Canadian literature in Translation exclusively. Therefore, we would like the title and the description to reflect more accurately the contents of the course. This is especially desirable for minors and majors in Canadian Studies who may wish to include FREN 341-3 in their degree program as a course with "Total Canadian content".

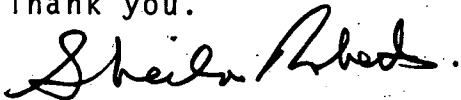
The Faculty of Arts Curriculum Committee has approved the principle that students be permitted to transfer from intensive Language courses to single semester courses without penalty.

"That the Faculty of Arts Curriculum Committee approves late transfers from intensive courses to lower courses."

The rationale for this motion lies in the fact that some students who enter intensive 8 hour courses find that they are unable for a variety of reasons, to complete the entire course, but would be capable of completing the beginning portion of the course, which is equivalent to the 4 hour introductory course. e.g., Students in Spanish 104-8 may have completed or could complete Spanish 102-4 although they are unable to finish the 8 hour course. In order to accommodate such students, and to optimize their learning experiences, it is proposed that such students be allowed to drop Spanish 104-8 and to enter a section of Spanish 102-4, even though Spanish 102-4 is not being offered to students in any given semester. The Dean has been assured that any such arrangement will not incur additional costs, and that the Department of Languages, Literatures and Linguistics is responsible for insuring that students receive adequate counselling, instruction and support to complete the reduced load within the original budget allocated to the intensive course.

Registrar's Note, - following SCUS meeting of June 6, 1978 -

The intent is to permit individuals who are attempting Intensive Language Courses to transfer other than during the normal course change period to a Lower Course in the Language being offered in the same period. Where such change occurs in the regular change period, the student would be entitled to any refund applicable under normal regulations, where the transfer is effected after the normal change period no refund would apply.
