Actions taken by the Senate Committee on Undergraduate Studies at its meeting of May 15, 1979 give rise to the following motions:

MOTION I

"That Senate approve, as set forth in S.79-69, the change of requirements for upper division work in the Department of Economics and Commerce."

MOTION II

"That Senate approve, as set forth in S.79-69, the change in requirements for prerequisite purposes in the Department of Economics and Commerce 'in order that a course be accepted as fulfilling a prerequisite a student must obtain a grade of C- or higher.'"

MOTION III

"That Senate approve, as set forth in S.79-69, the change in Calendar language and requirements for ECON 101-3 - The Canadian Economy, ECON 102-3 - Twentieth Century Economies, COMM 103-3 - Business in Society."

It is not intended that the changes in Motions I, II and III be rigidly applied until such time as they appear in Calendar in 1980 but that students could be advised by the Department with appropriate phasing in prior to that time.

RECAPITULATION

DEPARTMENT OF ECONOMICS AND COMMERCE.

B. UPPER DIVISION WORK

P. 109 Change of Requirements FROM: Normally, students will not be permitted to take the Department's Upper Division courses (courses numbered 300 and 400) during their first 60 hours without permission of the Chairman of the Undergraduate Program in Economics and Commerce.

To: Normally, students will not be permitted to take the Department's Upper Division courses (courses numbered 300 and 400) during their first 60 hours without permission of the Chairman of the Undergraduate Program in Economics and Commerce. Department majors will normally be expected to include 45 Upper Division credit hours in their last 60 hours.

RATIONALE

These are the standards the Department wishes to have maintained by all Economics and Commerce majors.

p. 109:

Additional Requirement

ADD: In order for a course to be accepted as fulfilling a prerequisite, a student must have obtained a grade of C- or higher.

RATIONALE

To ensure that students will be qualified to undertake successfully the material covered in the subsequent course.

Such standards are required of all students who obtain transfer credit from other institutions.

Change in Calendar Language

Economics 101 Students with credit for Economics 200 and/or Economics 205 may not take this course for further credit.

Rationale: For those students who have completed Econ. 200 and Econ. 205, Economics 390 is available and should be taken instead of Econ. 101.

Economics 102 Students with credit for Economics 200 and/or Economics 205 may not take this course for further credit.

Rationale: For those students who have completed Econ. 200 and Econ. 205, Economics 395 is available and should be taken instead of Econ. 102.

Commerce 103 Students with nine credit hours of 300/400 *division* Commerce courses may not take this course for further credit.

Rationale: After a student proceeds into his third year at Simon Fraser University, majoring in Commerce, it appears inappropriate to have him take Comm.103. Alternatives available are Comm. 403, Comm. 477, and Comm. 478.
