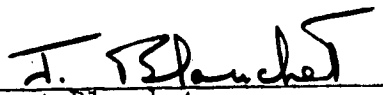

I am contacting you at the request and in the absence of the Director of the Centre for Canadian Studies.

At the meeting of 27 August, 1980, the Canadian Studies Steering Committee passed the following motion:

"that FREN 301 and FREN 302 be added to the list of Group B courses in the French Canadian Studies Certificate Program."

It was originally considered unnecessary to include these two courses in Group B, as it seemed unlikely that students would wish to apply a 300-level French course to their French Canadian Studies Certificate. (Six hours of Group B courses are required for the completion of the Certificate; transfer credit equivalent to or completion of FREN 301 and FREN 302 represent considerably more than six semester hours.) However, it is now apparent that some students do wish to apply FREN 301 and 302 to their certificate requirements.

Could you please arrange that this change to the curriculum of the French Canadian Studies Certificate Program be considered as soon as possible by the Undergraduate Curriculum Committee of the Faculty of Interdisciplinary Studies.
