3) Rationale

With the change in credit hours for Ballet (FPA.225, 226) it becomes possible for students to fulfill lower division requirements by taking only dance courses. This was not the original intent of the program. Therefore, in order to insure distribution at lower levels, we are requiring one lower level course in the arts outside the Dance area among the 30 required hours in FPA. Thus, the total number of lower division credit hours does not change, but the number of specifically designated hours is to be increased from 21 to 24. The other 6 credit hours may be chosen from among any other courses in the Centre (including ballet courses).

We have added FPA.140 and 136 to the list of suggested courses in order to bring the list current with courses available now within the Centre for the Arts.

3) Rationale

As with the other ballet courses (FPA.125, 126), a theoretical component is necessary. The course currently meets for 6 hours of studio work per week and will also include the preparation of a demonstration and a theoretical paper. The number of credits given for this kind of work is more appropriately 3.

Proposed Calendar Change for FPA. 382-3

1) Present Calendar entry:

FPA.382-3 Aesthetics of Performance

This course will examine theatre, dance, and film as public arts. Relationships of form and meaning among these and other modes of performance will be investigated through topics that may vary from semester to semester. This course is specifically designed for students of theatre, dance and film. (Lecture/Tutorial)

2) Proposed Calendar entry

FPA.382-3 Aesthetics of Performance

This course will examine theatre, dance, and film as public arts. Relationships of form and meaning among these and other modes of performance will be investigated through topics that may vary from semester to semester. This course is specifically designed for students in all study areas of the Centre for the Arts. (Lecture/Tutorial)

Prerequisites: at least 45 semester hours credit or permission of the department.

3) Rationale:

The content of this course is also salient for students of visual art and music. The prerequisite has been added because this is an upper levels course.

Proposed Curricular Change for FPA.234-3 Introduction to Film StudiesCalendar Description:

An introduction to the theory of film and its subsystems (genre, narrative, structure, semantics). This course is concerned not so much with individual film or techniques, as with the general cinematic capability itself, as varyingly theorized since the beginning of the century. The goal of film theory has been to formulate schematic notions of the capacity of the film medium. Various theories and theoretical positions will be assessed and compared in terms of their related cinematic practice and ideological functions.

PREREQUISITE: FPA.136-3 or FPA.137-3.

Proposed Change:

PREREQUISITE: FPA.136-3 or FPA.137-3 and permission of the Department.

Rationale

Comparable admission procedures should be used for FPA.234-3 as for Film production courses at the same level.

Proposed Calendar Change for FPA.456-3 Conceptual approaches to Drama

1) Present Calendar entry:

An intensive examination of some plays by Shakespeare leading to the development and classroom performance of new conceptual approaches to the plays.

2) Proposed Calendar entry:

An intensive examination of selected plays by a single major author such as Shakespeare, Ibsen, Beckett, or Brecht, leading to the development and classroom performance of new conceptual approaches to the plays.

3) Rationale:

The purpose of this change is to give faculty the option of choosing a major author other than Shakespeare for this course. This is desirable because students encounter Shakespeare's plays prior to the 400 level courses. Shakespearean texts are often used as a resource in acting and production courses. The comprehensive study of a major author other than Shakespeare will introduce new material to any group already having extensive experience with Shakespeare. As students will still undertake an intensive study of a single author, the proposed change will add flexibility to the course content without altering the pedagogical objective.
