Group Requirements

The Faculty of Arts Curriculum Committee at its meeting of November 22, 1982 approved the attached changes to the Group Requirements Section of the Faculty of Arts Regulations. The majority of these changes are of an editorial nature, in an attempt to make the requirements less confusing to students. There is one substantive change which is to remove Business Administration courses from Group B. The Faculty of Business Administration has excluded these courses from their Group Requirements, and, because of changes in their curriculum, there are almost no lower-division courses of general interest nature which students might use for satisfying Group Requirements.

GROUP REQUIREMENTS

Normally, the first 60 hours of a student's program comprise a period of exploratory and prerequisite study, contrasted to the final 60 hours which constitute the essence of the degree program. The Faculty of Arts Group Requirements outlined on p. 35 are intended to provide a base for a liberal arts degree. Students are well advised to take these Group Requirements early in their programs. The Group Requirements may include the lower division prerequisites for an Arts degree with a Major in Arts or a Double Major in Arts and Sciences.

The Groups for the purpose of this requirement are listed below:

English (excluding ENGL 010-3)
History
Languages, Literatures and Linguistics
Philosophy
Humanities (students must take courses from at least two Group A departments other than Humanities)

Group B -

which may be counted only under Group C)
Political Science
Psychology

Group C -

Biological Sciences
Chemistry
Mathematics
Physical Geography:
GEOG 111, 112, 313, 314, 315, 317, 318,
413, 414, 415, 416, 418, 419.
When used for Group C purposes, these
courses do not count toward the minimum
courses required to be taken in the Faculty of
Arts, i.e. 70 hours for Majors; 82 for Honors.
Physics

Students may substitute up to a maximum of 6 hours of courses taken in Interdisciplinary Studies, for courses required in Group A, B, or C, with the constraints that a maximum total of 3 hours may be substituted in any one group, and that the remaining 9 hours in Group A or Group B must be taken from at least two Arts departments. Interdisciplinary Studies courses so applied to Groups A or B will count towards the 70 required hours in the Faculty of Arts. The specific allocations follow:

NOTE: Transfer students with General Elective credit should consult the Office of the Dean of Arts regarding possible allocation to Faculty of Arts Group Requirements.

General Program

At least 120 semester hours of credit which include:

- A minimum of 12 semester hours in courses in Group A, including courses from at least two different Group A departments;
- A minimum of 12 semester hours in courses in Group B, including courses from at least two different Group B departments**;
- A minimum of two courses in Group C**;

Note: Courses taken outside one's Major department as part of the Group Requirements, i.e. a), b), and c) above, may be counted towards Requirement d).

- A minimum of 30 semester hours outside one's Arts Major department;

Note: At present, for purposes of this requirement, courses designated as ECON, BUS., and BUEC, are considered as being in a single department.

- The lower division prerequisites for at least one Arts Major program;

(**Note:** These semester hours may be counted towards the appropriate Group Requirements above.)

- A minimum of 45 semester hours in upper division courses including a minimum of 30 hours in an Arts Major program*;
- At present a minimum of 70 semester hours in Arts and Business Administration courses.

*A department may designate up to 8 credit hours of program related upper division courses offered by other departments, as being acceptable in fulfilling part of this requirement.

**Students may apply a total of 9 hours only of Geography courses toward satisfying the Faculty of Arts Group Requirements, specifically Groups B and C (see designated Physical Geography courses).

Honors Program

At least 132 semester hours of credit which include:

- A minimum of 12 semester hours in courses in Group A, including courses from at least two different Group A departments;
- A minimum of 12 semester hours in courses in Group B, including courses from at least two different Group B departments**;
- A minimum of two courses in Group C**;

Note: Courses taken outside one's Honors department as part of the Group Requirements, i.e. a), b), c) above, may be counted towards Requirement d).

- A minimum of 30 semester hours outside one's Arts Honors department;

Note: At present, for purposes of this requirement, courses designated as ECON, BUS., and BUEC, are considered as being in a single department.

- The lower division prerequisites for at least one Arts Honors program;

(**Note:** These semester hours may be counted towards the appropriate Group Requirements above.)

- A minimum of 60 semester hours in upper division courses including a minimum of 50 hours in an Arts Honors program*;
- At present a minimum of 82 semester hours in Arts and Business Administration courses.

*A department may designate up to 12 credit hours of program related upper division courses offered by other departments, as being acceptable in fulfilling part of this requirement.

**Students may apply a total of 9 hours only of Geography courses toward satisfying the Faculty of Arts Group Requirements, specifically Groups B and C (see designated Physical Geography courses).

Group C — Faculty of Science

Mathematics
Physical Geography:
GEOG 111, 112, 313, 314, 315, 317, 318, 413, 414, 415, 416, 418, 419.
When used for Group C purposes, these courses do not count toward the minimum courses required to be taken in the Faculty of Arts, i.e. 70 hours for Majors, 82 for Honors.
Physics

Group D — Faculty of Education

Any credit courses formerly entitled PDC or SPF or currently entitled EDUC excluding EDUC 401, 402, 405.

Group E — Faculty of Interdisciplinary Studies

Any credit courses entitled
General Studies (G.S.),
Centre for the Arts (FPA),
Communication (CMNS, formerly CC&A),
Computing Science (CMPT),
Criminology (CRIM),
Kinesiology (KIN),
African/Middle Eastern Studies (AME),
Canadian Studies (CN.S),
Latin American Studies (LAS),
Women's Studies (W.S.),
former Behavioral Science Foundations (BSF).

Students may substitute up to a maximum of 6 hours of courses taken in Group E, for courses required in Group A, B, or C, with the constraints that a maximum total of 3 hours may be substituted in any one group, and that the remaining 9 hours in Group A or Group B must be taken from at least two Arts departments. Group E courses so applied will count towards the 70 required hours in the Faculty of Arts. The specific allocations follow:

Latin American Studies	B
Women's Studies	B
Computing Science	C
Kinesiology	C
