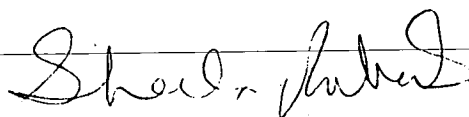

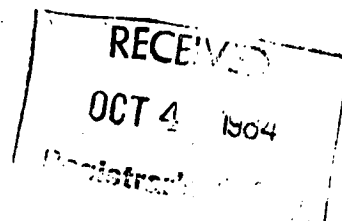

Program Two - Individual Program

A student may choose a program designed to meet his/her particular needs in Geography and also to allow greater flexibility in pursuing his/her own interests.

The student must consult with a Faculty Adviser who would undertake to supervise the proposed program and submit it to the Undergraduate Studies Committee. Normally the submission would take place prior to the fifth semester. Also, the submission would be supported by grades of B or better in geography courses. The Committee shall approve the program as submitted, suggest revisions, or reject it.

Students who choose this option must fulfill the Faculty of Arts requirements, and those of the Department, up to, and including item "a" of major or honors requirements listed above.

The changes are being made in order to simplify the language of the entry and to clarify the requirements for the program.

Further, the department found that some students chose this option as a device to not fulfill the normal basic requirements for a major or honours degree. The third paragraph blocks this loophole.
