Following the review by PACUP and the President's proposals in September, 1984, the Dean of Arts in response to instruction from me placed a number of motions before the Faculty of Arts Graduate Studies Committee relative to the discontinuation of M.A. and Ph.D. Programs in Russian and German. These motions were approved at a meeting of the Faculty Committee on December 6, 1984 (see attachment A) and were later approved by the Senate Committee on Graduate Studies at its meeting of December 18, 1984 (see attachment B).

It is therefore my intention to place before SCAP the following motions for consideration:

MOTION 1: "That the M.A. and Ph.D. programs in German be discontinued."

MOTION 2: "That the M.A. and Ph.D. programs in Russian be discontinued."

Note: 1. At present there are no students in either program.

2. No new students will be admitted to either program.

3. It is understood that there may be a restructured DLLL. Proposals regarding structure could come forward later for consideration.

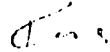

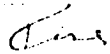
