(Suggested by SCUS on September 14, 1999.)

DEPARTMENT OF GEOGRAPHY
NEW PROGRAM

Geography - Environmental Specialty Honors Program

Students must complete all the requirements for the Environmental Specialty major (see above) plus GEOG 301-4 (Geographic Ideas and Methodology) and GEOG 491-4 (Honors Essay). A total of 132 semester hours is required of which 60 must be at the upper division. To graduate with Honors, students must have grade point averages of not less than 3.00 (Cumulative, Upper Division, and Cumulative Geography). Entry into the honors program requires the approval of the department and admission GPAs of 3.00.

RATIONALE:

Because the Environmental Specialty Major has 54 hours of required upper division courses, it can easily be upgraded to Honors with the addition of a theory and methodology course and the Honors essay.
