Student Discipline Summary – 2000/2001

Case #	Nature of Offence	Outcome
01-1	Cheating in final examination. Copied work from another student.	Student admitted academic dishonesty. Penalty imposed by Department (F in course) to stand, and student suspended for one semester.
01-2	Cheating in final examination. Allowed student to copy from own work.	Tribunal found student committed academic dishonesty and recommended one semester suspension. President suspended student for one semester. Student appealed to SCODA.
01-3	Cheating in mid-term examination Copied work from another student.	Student appealed departmental finding of academic dishonesty. Tribunal denied the appeal. Penalty imposed by Department (F in course) to stand.
01-4	Submission of same assignment for two different courses.	Referred back to Department for departmental action.
01-5	Submission of forged mid-term exams as original work.	Student admitted academic dishonesty. Tribunal recommended permanent suspension from the University. President reduced penalty to six semester suspension.
