My teaching and research interests focus on the investigation and exploration of opportunities to develop a better understanding of the relationship between people and technology as part of our effort to 'humanize' technology. I have been inspired by what these individuals have had to say about the place and value of teaching, and am curious to see how this gets translated into action on a university-wide scale by such a senate committee. In short, I am dedicated to teaching as a fundamental value of university life and want to participate in an administrative organ that has as its primary objective the promotion of this value. Re: SPCSAB

I am a full professor in the department of Molecular Biology and Biochemistry, with an active research program studying how genes are expressed and regulated in model organisms such as the fruit fly, *Drosophila melanogaster*. In terms of service relevant to this nomination, I have a fair amount of experience at the departmental and faculty levels (tenure, undergrad, grad, hiring, advisory, and other committees). I also have relevant service outside the university: the Research Foundation, the National College of Reviewers of Canada Research Chairs, NSERC Grants Selection Committees, and various panels for the BC Health Research Foundation (Operating, Equipment and Scholarship grants), as well as membership in various professional societies.

However my service at the university level has been limited to the President's Research grant committee, and the Senate Committee on Teaching and Learning (SCUTL). Recently I have become more interested in the "bigger picture", as a result of having to deal with issues raised by documents such as the Krebs curriculum review.
