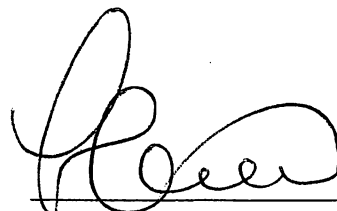

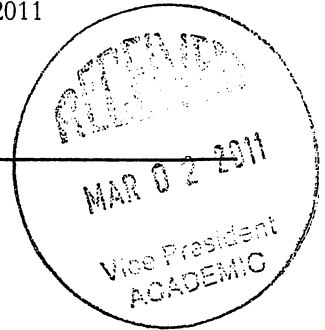

Jon, after numerous discussions with a variety of individuals involved with the Centre for Coastal Studies the Director and I have concluded that for the Centre to capture more accurately its guiding vision and what it does we need to assign a new name to it. We would like to propose the "Centre for Coastal Science and Management".

This has the unanimous approval of the Advisory Committee. The lion's share of the research and outreach associated with the Centre has to do with better understanding natural/environmental science in coastal waters (both fresh and saltwater) and the management/policy challenges that flow from this research and outreach. This name change will complement two other new initiatives in FENV – the Hakai Network and the Liber Ero Chair (shared among Science and FENV).

I have attached a recent analysis of the activities of the Centre. I am sure you will agree that this name change will more accurately reflect the responsibilities of the Centre.
