At its meeting of October 23, 2013 the School of Criminology Graduate Program Committee approved:

- 1) two proposed program changes:
 - a. delete CRIM 869-3: Professionalism and Criminal Justice from the Criminology Master of Arts, practicum option
 - i. **How the change will affect the existing program:** The course will no longer be required for completion of the program. There will be no impact on students currently in the program.
 - ii. **Rationale:** This course is no longer needed as a means of acquainting inexperienced students with the context, practices, and ethical issues associated with the professional criminal justice work environment. The great majority of those who are interested in the program are currently working in the CJS. Those who are not, receive orientation through the program placement and their faculty supervisor. In addition, the number of students in the program at any given time has almost always been too low to meet the minimum enrollment required to offer the course.
 - b. Add CRIM 864-3: Research Methods V: Advanced Qualitative Methods as an additional optional course for the Criminology Master of Arts, thesis option and Criminology Doctor of Philosophy programs
 - i. **How the change will affect the existing program:** Students will have an additional course option for completion of program requirements.
 - ii. **Rationale:** The course will provide additional options for the students to meet program requirements.
- 2) four minor course changes: CRIM 863-3, CRIM 865-3, CRIM 880-3 and CRIM 885-3
 - a. **Rationale:** CRIM 869-3 should be removed as a prerequisite for CRIM 880 and CRIM 885 since this course is being deleted. The existing prerequisites for CRIM 863 and CRIM 865 are too restrictive given the backgrounds of our students.



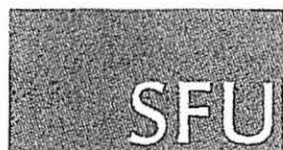

Issues pertaining to ethical integrity of students who are not in the Clinical Program are subject to the same codes of conduct and will follow the same procedures as described above, but will be handled directly by the graduate studies committee.

A student may appeal the decision to the GSC of the department. The GSC will adjudicate the appeal using procedures outlined in graduate general regulation 1.8.2 Review of Unsatisfactory Progress. The grounds for appeal are errors or unfairness in the procedures that were followed.
