The University's residency requirement stipulates that, in most cases, total transfer and course challenge credit may not exceed 60 units, and may not include more than 15 as upper division work.

The University's residency requirement stipulates that, in most cases, total transfer and course challenge credit may not exceed 60 units, and may not include more than 15 as upper division work. **The School of Communication requires that a minimum of 16 upper division CMNS units (four CMNS upper division courses, including at least one 400 division CMNS course) must be taken at SFU. Directed study and field placement courses may not be used to meet this requirement.**

Rationale:

Change from 45 to 44 upper division units to match SFU's general requirements for a BA degree.

Specify CMNS requirements for how many upper division courses and units within CMNS are required to be taken at SFU, rather than elsewhere (e.g., by transfer or exchange credit), to be in line with SFU's requirement of taking 2/3 of upper division units at SFU (30 units out of 44 or 45 units total).
