A policy was approved in 2001 (S.01-24) regarding the temporary and permanent withdrawal of graduate courses. The purpose of this policy is to keep the SFU calendar updated so that it provides accurate information to prospective and current students. The Graduate Studies office is required to send a list of graduate courses, which have not been taught in the previous four academic years (or more), to the academic units for review before the courses are temporarily or permanently withdrawn from the calendar. This list of courses was sent to the academic units in October 2015 for review.

The Dean of Graduate Studies is required to present to the Senate Graduate Studies Committee a list of the courses to be temporarily withdrawn for approval. A list of courses that the academic units requested *not* be temporarily withdrawn, have also been included for information.
