Attached for consideration by the FCAT Graduate Studies Committee is a Graduate Course Change recommending that CMNS 835 be changed from a 3-credit to a 5-credit course. 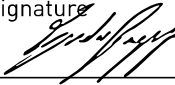

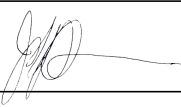
