

Calendar Entry Change for Masters of Public Policy

Summary of change:

We propose to make PLCY 821 – Indigenous Policy a required course for the MPP degree. It is currently an elective course in the School of Public Policy. We will reduce the number of required elective courses to three from four for those doing PLCY 809 – Major Research Project, and to four from five for those doing PLCY 835 – Extended Policy Analysis to complete the research requirements of the Masters of Public Policy (MPP) degree with the same total number of courses (14). We will teach PLCY 821 in Spring semester of students' first year in the program and will move PLCY 804 (the required course currently taught in Spring semester of first year) to Fall semester of their second year to keep the number of required courses in first year at four per semester.

Rationale for change:

It is vital that our graduates have taken Indigenous Policy as a required course given its importance in Canadian public policy. As the majority of our students will work in Canada, we feel a designated required course is the best way to ensure students receive the necessary background in and understanding of Indigenous policy issues.

Effective term and year:

Fall 2022

Will this change impact current students? If yes, what is the plan for current students?

No. This change retains the number of total credits at 70 (14 courses) required for the MPP degree. Students who are currently in their first or second year of the MPP program will not have to take Indigenous Policy as a required course.

Attached please find a calendar change form requesting an update to the program requirements for the MRM Planning program.

The change is the removal of one required course (REM 601) and addition of another required course (REM 644) for the MRM Planning program. The rationale is that this change better aligns the planning program with the Professional Standards Board (PSB), Canadian Institute of Planners (CIP) planning competencies and helps to retain its accreditation. REM 644 addresses several competencies that are not currently met with the existing required courses. The REM executive has voted in favour of this change.

<p>Summary of change: Remove one required course (REM 601) and add another required course (REM 644) from the MRM Planning program</p>
<p>Rationale for change:</p> <ul style="list-style-type: none"> - The planning program needs to be aligned with the PSB CIP planning competencies to retain its accreditation. REM 644 addresses several competencies that are not currently met with the existing required courses. - Policy is an important component of planning education, regardless of the formal PSB competencies. Many job descriptions for planning and planning related positions our students and graduate apply for ask for policy knowledge. The materials/content taught in REM 644 are not sufficient addressed in our required planning course. In addition, the undergraduate equivalent course, PLAN 400, is a required course.
