Attached are three reports for information:

- 2023/24 Grades Report: This report is prepared once a year and it summarizes course grades at the University over a ten-year period. The 2023/24 Grades Report covers the period from 2014/15 to 2023/24. Attached is the Summary Report. - 2023 Undergraduate Student Survey (UGSS) Report: The UGSS survey is conducted every fall term. The attached report presents a summary of key findings from the Fall 2023 survey. Topics covered are selected in consultation with faculties, Student Services and other administrative units of the University. This year's topics included: course availability, credential planning and completion, teaching and curriculum, services, and university culture and environment. - Effect of COVID/Grading Policies on Grades/Performance: At the September 2023 meeting of Senate, it was requested that IRP provide some data related to the preparedness of incoming undergraduate students in COVID vs. pre-COVID times, as well as the effect of various recent grading policies on undergraduate course grades. This report was prepared to meet that request.

2023/24 Grades Report:

Executive Summary of Undergraduate and Graduate Course Grades

2014/15 to 2023/24

This report summarizes patterns in student course grades at Simon Fraser University over the ten-year period from 2014/15 to 2023/24¹. Grades are reported on a GPA scale. SFU faculty, staff, and senators can access a report with more detailed tables and charts (https://www.sfu.ca/irp/students/grades-report.html).

Effect of the COVID-19 Pandemic and Recent Grading Policies

- A combination of changes to grading policies and other effects of the COVID-19 pandemic coincided with a bump in average course grades at the undergraduate level.
- This bump occurred in both lower division (LD) and upper division (UD) courses.
- The pattern was seen in every faculty.
- The increase in average grade awarded began in 2019/20 2020/21, then tapered off, so that by 2022/23 the grades appeared to be following their pre-pandemic pattern (which was a slightly increasing trend).
- However, the one-time grading policy in Fall 2023² has coincided with a new bump in average course grades.

10-Year Patterns

- Even ignoring the grading pattern associated with the COVID-19 pandemic and recent grading
 policies, over the past ten years, the average grade awarded in courses has shown a gradually
 increasing trend in all faculties at the undergraduate level, and most faculties at the graduate
 level.
- Comparing grades in 2014/15 versus 2023/24, all *increases* of at least 0.30 occur at the lower division level, and include average course grades awarded by:
 - the Faculty of Education (+0.65),
 - o the Faculty of Environment (+0.42), and
 - the Faculty of Arts and Social Sciences (+0.33)
- There are no faculty-level decreases of at least 0.30.
- Over the last decade, the Faculty of Education has awarded the *highest* average grades in most years in both undergraduate and graduate courses.
- In most years, the *lowest* average course grades have been awarded by:
 - o LD: the Faculty of Science
 - UD: the Faculty of Arts and Social Sciences
 - Grad: the Beedie School of Business
- Graduate courses have consistently awarded higher average grades than upper division courses, which have awarded higher average grades than lower division courses, in all faculties.

2023/24 Course Grades

- The average course grade this year was 3.05 in undergraduate courses (LD: 2.95; UD: 3.19), and 3.74 in graduate courses.
- Among faculties, the Faculty of Education awarded the highest proportion of A grades and the
 highest average grades this year in lower division and upper division courses. In graduate courses,
 the Faculty of Environment awarded the highest proportion of A grades, and the Faculty of
 Science awarded the highest average grades.
- Among faculties, the lowest average grades were awarded by:
 - LD and UD: the Faculty of Science
 - Grad: the Beedie School of Business
- The subjects awarding the highest and lowest average grades this year were:
 - Highest average grades:
 - LD: PUNJ (4.12)
 - UD: DIAL (3.92)
 - Grad: MASC (4.33)
 - Lowest average grades:
 - LD: FAN (2.43)
 - UD: MACM (2.62)
 - Grad: ACMA (3.37)
 - O Note that MASC and ACMA at this level awarded fewer than 20 grades this year.
- A few course subjects have shown a large change (at least 0.40) in average grade awarded from last year to this year.
- Subjects with a large *increase* include:
 - o SCI (UD: +0.75)
 - o COGS (UD: +0.50)
 - o SD (UD: +0.49)
 - o ITAL (LD: +0.47)
 - APMA (Grad: +0.43)
- Subjects with a large *decrease* include:
 - o ACMA (Grad: -0.48)
- Note that ACMA awarded fewer than 20 grades at the graduate level each year, so significant year-to-year variability is not unexpected.
- This year, courses offered by the Faculty of Applied Sciences had the highest use of the P/CR/NC grade scale (via the Elective Grade System and/or the Fall 2023 Grading Policy); P/CR/NC grades made up 11% of their undergraduate course grades (LD: 11%; UD: 10%).
- This year, groups of undergraduate students who were most likely to make use of the P/CR/NC grade scale in their undergraduate courses include:
 - Faculty of Health Sciences students taking Faculty of Applied Sciences courses (18%),
 - Faculty of Communication, Art and Technology students taking Faculty of Applied Sciences courses (15%), and
 - Beedie School of Business students taking Faculty of Science courses (15%).

Student Faculty vs Course Faculty (Undergraduate Students in Undergraduate Courses)

- Student Faculty:
 - o Students in a given faculty most frequently took courses from their own faculty.
 - Students from all faculties received their highest average grades in Faculty of Education courses.
- Course Faculty:
 - Courses in a given faculty were most often taken by students from that same faculty.
 - The exception is courses from the Faculty of Environment, which were most frequently taken by students from the Faculty of Arts and Social Sciences.
 - In terms of how courses in each faculty awarded grades to students from different faculties:
 - Courses in the Faculty of Applied Sciences awarded the highest average grades to Faculty of Applied Sciences students.
 - Courses in the Faculty of Health Sciences awarded the highest average grades to Faculty of Health Sciences students.
 - Courses in the Faculty of Science and the Faculty of Arts and Social Sciences awarded their highest average grades to students from the Faculty of Science.
 - Courses from the remaining faculties awarded their highest average grades to students from the Beedie School of Business.
