Motion:

That SGSC approve the modification to GGR 1.3.6c Admission to an Accelerated Master's.

Summary and Rationale:

An accelerated admission to a master's degree program is an existing pathway for highly qualified undergraduates to take graduate courses that would apply to a future master's degree as well as to their undergraduate degree. The current Graduate General Regulations incorrectly omit the term "pathway" and instead describe the process as formal admission to master's study. Rather than admission to master's study, it is permission for an undergraduate student to enroll in up to 10 units of graduate coursework that can be applied to both the undergraduate degree and a subsequent master's degree.

The current policy requires a very high minimum cumulative grade point average (CGPA) for accelerated master's applicants, higher than is currently required for applicants with a bachelor's degree to enroll in a doctoral program. The high minimum CGPA eliminates many deserving applicants from consideration for the accelerated pathway. In particular, it discriminates against students who took difficult courses early in their undergraduate careers or who enrolled in courses outside their comfort zone. Individual academic units are the bodies best positioned to determine whether a student is an appropriate candidate for the accelerated master's pathway.

It is proposed that the minimum CGPA be reduced from 3.67/4.33 to 3.33/4.33; or 3.5/4.33 for the last 60 units of course credits. Academic units would continue to be able to require higher minimums.

For comparison, the minimum GPA requirements for admission to graduate study through the regular pathway are as follows:

Applicant to master's study with a bachelor's degree: CGPA of at least 3.0/4.33 (B), or a grade point average of at least 3.33/4.33 (B+) based on the last 60 units of undergraduate courses.

Applicant to doctoral study with a bachelor's degree: a bachelor's degree, with a cumulative grade point average of at least 3.5/4.33, or a grade point average of at least 3.67/4.33 (A-) based on the last 60 units of undergraduate courses.

As requested by SGSC, mean CGPAs for the most recent undergraduate graduands are provided below.

Admission to a graduate program is not guaranteed, and academic units may set higher grade point minimums.</p> <p>b) Submitted evidence from qualified referees of the student's ability to undertake advanced work in the area of interest.</p> <p>Students must satisfy any additional requirements set by the admitting academic unit's graduate program committee.</p> <p>A maximum of 10 graduate course units, used either as electives or upper division required courses at the bachelor's level, can be applied to the requirements for the master's degree.</p>
