SIS is renewing our curriculum. This will be a core course for the optional concentration that is proposed to be titled 'International Development, Inequality, Environment, and Shared Futures'.

This new course will replace a previous course (IS265) that was titled 'Global History from the Revolutionary Age to the Present'.

The proposed title and course description of the new course are intended to more clearly identify the core concepts of focus in the course (empire, anti-imperial struggles, colonization, decolonization) and to thereby more clearly advertise to students the content of the course.

These changes ensure better integration with the upper division courses that build on from this course (e.g. IS358 'Development, Aid and Difference in Historical Perspective' and IS419 a special topics course that IS instructors have taught as 'Decolonization & Its Discontents').
