

Action undertaken by the Senate Committee on Undergraduate Studies at its meeting of December 5, 2024 gives rise to the following recommendation:

Motion

That SCUP approve and recommend to Senate the termination of the Humanities Honours Program in the Department of Global Humanities within the Faculty of Arts and Social Sciences, effective Fall 2025.

The relevant documentation for review by SCUP is attached.

Proposal to Terminate Humanities Honours Program

1. All impacted credentials, levels and categories of the degree, and specific discipline or field of study: Humanities Honours
2. Location of the program: Burnaby
3. Faculty(ies), Department(s), or School(s) offering the program: Department of Global Humanities
4. Anticipated final dissolution date: Fall 2025
5. Reasons for termination of the program, such as:

Enrollment in the program was suspended in Summer 2017, and there has been no enrollment demand since. Sufficient time has passed to make the dissolution official.

6. Plan for phasing-out of program, including
 - a) Steps taken to consult with students: N/A since admission to the program was suspended starting Summer 2017 and any students still enrolled at that time have graduated.
 - b) Steps taken to consult with impacted instructors and staff: N/A since the program is not active.
 - c) Steps taken to ensure students in the program have the opportunity to complete the program: N/A; no students enrolled in the program.
 - d) Description of the reallocation of any remaining program and associated resources when program is terminated: N/A; no resources are currently allocated to the program.
 - e) Confirmation of consultation with other impacted departments and Faculties: no other units are impacted by the termination.
 - f) Impacts on and/or reorganization of curriculum in cognate disciplines: we foresee no impact on cognate disciplines.

g) Timeline of activities: considering the suspension of the program since Summer 2017, we would like to terminate the program as soon as possible so that it does not create any confusion by continuing to be listed on the Calendar.
