On behalf of the REM Undergraduate Program Committee, I request your approval for the termination of the Post Baccalaureate Diploma in Sustainable Development. We would like to terminate the program because it has not been very popular and completion times were generally long. The program was suspended in Summer 2020, and all students in the program have either completed or been discontinued. Hence, there are no students left in the program.
