Action undertaken by the Senate Committee on Undergraduate Studies at its meeting of March 6, 2025 gives rise to the following recommendation:

Motion

That SCUP approves and recommends to Senate the suspension of admission to the Dialogue Minor in the School of Communication within the Faculty of Communication, Art and Technology.

## Proposal to suspend admissions to a program

**NOTE:** Suspension of admissions to a program does not result in the termination of a program. After a program has been suspended for at least two semesters, an academic unit follows the process to terminate the program. Or, if no students are currently enrolled in the program, academic units can consider the fast track option.

**1. All impacted credentials, levels and categories of the degree, and specific discipline or field of study**

Minor in Dialogue

**2. Location of the program**

Vancouver

**3. Faculty(ies), Department(s), or School(s) offering the program**

School of Communication, Faculty of Communication, Art and Technology

**4. Proposed date for suspension**

Fall 2025

**5. Reasons for suspension of admissions, such as:**

Required and elective DIAL courses have been temporarily withdrawn (DIAL 390W, DIAL 391W, DIAL 392W, DIAL 393, DIAL 394) effective Summer 2025, and the Semester in Dialogue has been suspended.

**6. Plan for suspension, including:**

There are only two students currently in the program, and both have completed all the requirements so will not be affected.

**7. Draft Calendar entry detailing suspension of admissions to the program:**

**Admission to this program has been suspended effective Fall 2025**
