Please see attached course forms for updated language. REM 802 was removed from the PhD program in 2020 but corresponding course deletion paperwork was never submitted. The course has not been offered since 2019. REM would like to add a three-unit option to its Directed Studies offerings. Course description is identical to REM 664 or 665, but a three-unit option. We feel that these are simple changes that could be included in the fall calendar even on short notice, but we respect the SGSC timelines and accept it may be necessary to wait until Spring 2026.


