POSITION OVERVIEW

Join the team driving global policy action on antimicrobial resistance challenges.

THE PROBLEM

Antimicrobial resistance (AMR) is one of the greatest threats facing humanity today. The overuse of antimicrobial drugs in humans, agriculture, and the environment has rendered antibiotics less effective. Without these essential health tools, infections that in the past were easily treated are now harder—and sometimes impossible—to treat.

The consequences of inaction on antimicrobial resistance (AMR) are far-reaching and threaten human health, the global economy, the environment, and global health equity. AMR is estimated to have contributed to almost 5 million deaths in 2019. By 2050, AMR is expected to cause 10 million deaths annually and cost the global economy \$100 trillion.

There is little evidence or tailored insight on what actions countries should pursue to mitigate or prevent the spread of AMR. Implementation of National Action Plans to reduce AMR has stalled in many countries. Governments around the world lack the necessary support to explore the merits of different policy interventions—such as legislation, taxation and other economic incentives, public awareness campaigns, and professional and business regulation—that could safely reduce antimicrobial use.

Addressing AMR requires collective, global, and multisectoral action informed by effective, evidence-based research and policy advice at the national and international levels. Global Strategy Lab bridges this gap between science and policy.



THE ORGANIZATION

Global Strategy Lab advises the world's governments and international organizations such as the World Health Organization and the World Organisation for Animal Health on how to design laws, policies, governance mechanisms, and institutions that address transnational health threats to make a healthier, more equitable world.

Our research focuses on three areas of public and global health research: global legal epidemiology, public health institutions, and global AMR. We are designated as the WHO Collaborating Centre for Global Governance of AMR and are the secretariat for both the International Network on AMR Social Science (INAMRSS) and the Global Health Law Consortium.

Building on our research and policy leadership on AMR, Global Strategy Lab has received substantial start-up funding to build a think tank to accelerate global action on AMR policy. The AMR Policy Accelerator is a new division of Global Strategy Lab with a mandate to undertake rapid and applied policy projects that leverage global science and insights to respond to urgent policy needs. This new mode of operation will expand Global Strategy Lab's policy impact.

The Accelerator will undertake three programs of work in its start-up phase: (1) provide **Advisory Services** to governments, international organizations, and civil society in response to requests for evidence on AMR policy, implementation, and evaluation; (2) work with leading experts in the field to generate actionable **Policy Research**; and (3) support policy development and research around the world through a suite of **Capacity Building**.

WHAT YOU BRING

We are looking for creative research leader who is enthusiastic about building our initiative to tackle AMR. You should have experience managing international research projects and experience working in low- and middle-income countries on AMR.

You also have project management experience of managing multiple and concurrent research projects. You have strong verbal and written skills, and a high level of judgement and tact in interacting with external stakeholders.

We are looking for someone with PhD related to public policy with a preference for applicants with a global health, One Health, or other health-related or -tangential field (including non-human health). Interdisciplinary backgrounds encouraged, strong methods background desired.

You will have advanced research design knowledge (quantitative, qualitative, mixed-methods). Strong data analysis and visualization skills sought. You will also have expertise in at least one core One Health sector (human, animal, agriculture, environment) related to AMR and knowledge of global policy and governance challenges using a One Health approach.

The Policy Research Lead will also be someone with experience working in low- and middle-income countries and/or resource-limited contexts, and who has experience providing advice to government.



SCOPE AND RESPONSIBILITIES

This is an exciting opportunity to deliver wider social impact on a global scale and to build a new initiative from the ground up. Reporting to the Accelerator's Managing Director, the **Policy Research Lead** will lead the design, oversight, and execution of the Accelerator's Policy Research program of work and engage with global AMR researchers and stakeholders.

The Policy Research Lead is an ideal person for someone who is excited about exploring and building interdisciplinary methodological approaches. You thrive in highly productive research environments that operate at a steady rhythm. You are excited about working with a global and diverse team of passionate and driven people with sensitivity to language, culture, and remote working arrangements. You also possess a high level of demonstrated leadership and strategic management (strategic thinking, team development, coaching a multidisciplinary team).

Specifically, the Policy Research Lead will:

Policy Research

- Provide leadership to the PR program of work by heading research design, data collection, and analysis of AMR policy research projects
- Manage concurrent research projects with competing priorities, ensuring that projects are adequately and appropriately planned (realistic, achievable, describing major activities and milestones)
- Manage a small team of research fellows
- Lead the development of background materials and academic outputs for knowledge mobilization purposes.
- Lead the development of expert workshops, policy dialogues, and capacity-building workshops
- Coordinate a global network of AMR researchers and working groups addressing key AMR policy issues
- Develop, expand, and manage the Accelerator's academic/research network and working groups for PR projects

Accelerator Leadership & Strategy

- Support the development and implementation of the Accelerator's knowledge mobilization strategy
- Support the development of a horizon scanning strategy, for systematically identifying new AMR evidence and policy priorities, with the Director of Policy.

Support to other Programs of Work

- Provide methodological advice and support, when necessary, to projects under the Advisory Services program of work
- Mentor interns as part of the Capacity Building program of work, which aims to develop and promote AMR knowledge and policy analysis skills among early career policy leaders around the world



COMPENSATION AND TERM OF EMPLOYMENT

The **Policy Research Lead** will be working remotely until in-person activities resume at Global Strategy Lab. Annual salary will range from **CAD\$76,500 - \$103,500**, depending on the individual's experience and education. The Lab's commitment to pay equity necessitates that we will not be able to offer a salary outside of the range provided. We also provide extended health care and dental benefits. Global Strategy Lab staff employees are also able to participate in York University's Tuition Fee Waiver Program. The successful candidate is expected to work approximately 40 hours per week; occasionally this role will require travel and evening and weekend work. The language of work is English. There is one position available.

Global Strategy Lab is based at York University in Toronto and new team members will benefit from close ties to the Lab's existing impact-driven research program and networks. The AMR Policy Accelerator and the rest of the Lab will be working remotely during COVID-19 and are open to flexible and remote working arrangements in the future.

Global Strategy Lab is committed to fostering an inclusive and equitable environment that celebrates people in all their diversity and encourages a variety of perspectives. We recognize that different experiences and viewpoints are a source of strength in collaboration, and the driving force behind innovative, creative, equity-minded, and globally oriented research.
