The guest emphasized the accreditation and international recruitment issues, and stated that the name change would not change the program content, structure or degree requirements.

Committee members recalled that the Assessment Committee for New Graduate Programs and SGSC argued strongly against the M.Sc. designation when the original program proposal went through the assessment and approval process. The Chair felt that the proposed degree name change would require the Ministry's approval. The guest departed at 2:57 p.m.

At 3:20 p.m., Dr. Peter Klein was invited to present the new program proposal, Master of Financial Risk Management. The program has been running as a cohort master's program under special arrangements. ACNGP recommended the full program proposal to SGSC for approval.

The university librarian's representative raised the issue that the Library was unable to make acquisition to support the program, without additional funding of approx. \$5,000. The Faculty disagreed with the Library's assessment.

SGSC recommended that the Library and the Faculty resolve the resource issue prior to a SCUP meeting. It was moved and seconded to recommend the new program proposal to SCUP for approval.
