5. Faculty of Health Sciences: Calendar changes [GS2008.03]

5.1. Renumbering courses

A table of HSCI, PPH and GLOH courses and respective graduate course minor change forms were proposed - renumbered to HSCI courses, as SGSC previously requested. A committee member noted that documentation for HSCI 826-3 (formerly GLOH 835) was omitted.

The committee asked that a note be added in the calendar that students cannot take the re-numbered course(s) again for credit, in addition to minor changes to conform to the requirements for calendar entries, e.g., fewer than 25 characters, shorter course descriptions.
