Master of Arts in International Studies

The committee reviewed the program proposal recommended by the Assessment Committee for New Graduate Programs for approval. The Chair agreed to disclose the identity of the external reviewers to ACNGP; the committee did not feel that the anonymity presented an issue. After discussion, the committee recommended approval of the program, subject to the following minor changes:

6. Faculty of Health Science

6.1. Overview of academic program plan

Dr. Craig Janes, was invited to provide an overview of academic program plan in Health Sciences. At 3:10 p.m., Dr. Janes presented the following outline:

- Timeline of program roll-out
- Internal/external pressures for program development
- Short-term plans for program changes and new graduate program research track M.Sc. in Health Sciences, PhD program, new concentrations of the MPH program, revision of the MPH program for accreditation, joint degree/certificate program in infectious disease, Master's programs for Surrey campus
- Expectation in the next six months

A committee member questioned the name of the degree; it was clarified that the M.Sc. was more theoretical and narrower, and MPH was more applied and broader. The committee observed that due to fiscal restrain, resources and overlap issues with collaboration, thus other faculties/departments should be informed and negotiation should be made, especially with premium fee programs.

The Chair thanked Dr. Janes for his presentation, and he departed at 3:30 p.m.

6.2. Master of Science program [GS2008.30]

M.Sc. program – Research option

A new stream or option was presented, with calendar changes, a minor course change and two new course proposals:

HSCI 801-4 Biostatistics for population health practice I

HSCI 804-3 Biostatistics for population and public health practice II

HSCI 805-3 Intermediate epidemiology

It was clarified that the originally approved M.Sc. program in Population & Public Health had a name change to Master of Public Health due to industry demand (with no changes to content or structure of the program). The faculty was advised by SGSC to present a research-based program as a new option of the master's program.

A committee member questioned students' ability to cope with the changes; funding and course requirement issues were discussed. Another committee member noted that SGSC spent considerable time debating the similarity of the

two degrees, and now the difference of the two degrees. It was noted that the faculty could admit students with insufficient background under conditional or qualifying admission. Another member expressed that a new option, with emphasis on research, would not require a notice of intent, and that courses other than the two new ones were already part of the existing M.Sc. program. Overlap issue of the new courses was resolved with the Department of Statistics & Actuarial Science. Library report for new courses was pending. Question of fee structure was raised.

The committee noted the following:

- Course descriptions too long
- Calendar entry minor typos; avoid reference to page numbers

It was moved and seconded to approve the new stream M.Sc. program, minor course change, two new courses, and calendar changes, subject to minor revision, as above noted, and forward to Senate for information.
