- <u>Proposed pilot-English Language and Graduate Studies Prep Program</u> BUS and ECON have agreed to pilot the program. A decision will be made as whether the program goes ahead on February 15. If approved, students will start May 28th and enter SFU in September.

5.1 Changes to Ethics Approval Verification

[dgs 12-1]

Associate Dean, Peter Liljedahl, outlined the current problems students have if a thesis title is revised following Ethics approval. Solution: revise the Approval of Examining Committee form to include a section where the senior supervisor signs that protocol is followed as per the initial proposal.

DGS will revise the paper trail to ensure instructions are the same for both Masters and PhD.

5.2 Minimum Attendance at a PhD Defense

In order to address the changes in technology, Associate Dean, Peter Liljedahl, presented a proposal to define who must be in attendance at a PhD defense. P. Liljedahl will send a revised proposal to the SGSC members and Graduate Program Chairs for feedback at the February SGSC.

5.3 Theses Withholds and Postponements

P. Liljedahl indicated that technical changes have made Witholds problematic. This proposal will get rid of the Withold category and use Postponement for one year. SGSC agreed. All relevant documents will be revised and P. Liljedahl will present the changes to graduate program chairs at the next gpc meeting.
