4. Chair's Report

The Dean has just returned from a Western Association of Graduate Schools (WAGS) conference in North Dakota where participants were invited to join a session at a Microsoft campus, one of the largest in the U.S. The Dean's "take-away" was that graduate studies needs to focus more on value-added programs and work-integrated learning (WIL). For example: a one semester business or management program, and more opportunities for students to learn how to work on a team. According to employers, work-integrated learning is the single most important variable in hiring graduate students.

The Dean is now on the WAGS Executive and has accepted invitations to visit UCLA and UWashington.
