6. Other business

The chair raised some questions for short discussion in regards to current challenges in graduate affairs.

GGR 1.7.6 Courses in Master's and Doctoral Programs was drafted for students who are completing graduate courses at other institutions. However, this policy also applies to SFU students who are taking graduate courses at SFU prior to being admitted to a program, including laddering programs. The regulation states that grades from the graduate course taken outside the program are not considered when calculating CGPA. SGSC was consulted if they thought if SFU graduate courses should be included in the CGPA calculation if they were taken prior to commencement of a program. The meeting attendees generally regarded that the grades should be included.

The GGRs prohibit courses graded on S/U grading basis not to be used towards a minimum course requirement. This policy is not being enforced and currently there are programs in violation of the policy. Having multiple S/U courses can result in an unfair weighting of a student's CGPA. A discussion was focused on the need for S/U and IP/CO as grading basis and how to balance its use to protect students.

A brief discussion was centered on the use of undergraduate courses in a student's graduate credential minimum requirements. It was seen that use of undergraduate courses allowed potential knowledge gaps to be filled and that admitting students as qualifying students to complete the undergraduate course work first is not always an option. A working group is being created to examine the use of cross-listed courses and ensuring that graduate students receive graduate value for the course.
