a) Program proposal: Graduate Certificate in Professional Heritage Resource Management (Cohort Special Arrangement)

It was suggested that the wording under Location of Program to be changed from "Online coursework coordinated through the Burnaby campus" to "Online delivery". Also, under Graduation Requirements, the completion time of two years should be changed to "the intended completion time is two years" as the graduate regulations allow up to three years for certificate completion time.

A concern was raised that the proposal gives the impression that the certificate is comprised of five courses. SGSC requested the proposal remove all references to ARCH 591.

b) New course: ARCH 591 Directed Studies

There was confusion regarding the rationale of this course. SGSC requested that "ARCH 591 is required to complement" be changed to "ARCH 591 will complement" in order to reflect that the course is not a required course. The course component of seminar and lab should be removed as no dedicated class space is required.

SGSC also recommended a future amendment to the HRM MA calendar language to show students may take this course in lieu of a required course with permission of the HRM director.
