It was noted that the change in units is consistent with the proposed increase in contact hours. The proposed changes would result in the six-week course becoming a 13-week course.

b) New course: BUS 570 Project Management

Concern was raised during the overlap check. It was discussed that while other project management courses currently exist at SFU, the particular merits of running a business-centred course would be the use of business-specific examples, it would make an assumption of previous cohort course knowledge and the online delivery could be consistent with the cohort courses.

It was suggested that students should not be permitted to take project management courses offered by different academic units for credit. SGSC discussed how project management courses are interdisciplinary and how there may be interest from students in other units to take these courses.

A concern was raised about fiduciary responsibility when students bring in real-world problems from their workplace to be discussed in class. SGSC discussed that it would be expected that students not share any confidential or sensitive material with the class. It was also discussed that student/peer evaluation should be limited.

An SGSC member questioned the facilitation of online group work. It was explained that the course platform used is specifically designed for collaborative group work.

SGSC discussed that there would be a potential to make project management and other professional development courses as stand-alone courses that would be offered for credit.
