School of Mechatronic Systems Engineering

Memorandum of Understanding: Fraser International College and Mechatronic Systems Engineering Pre-Master’s Program in Mechatronic Product Realization

SGSC had concerns about setting a precedent for lowering admission standards as this can potentially lead to admitting an entire cohort with a lower admission requirement.

SGSC recommended that a number cap is placed into the agreement on the number of students per intake to ensure the department can handle the number of students if they all successfully complete the FIC program.

It was recommended that some oversight or monitoring is added to the FIC-Pre Master's Program.

It was agreed that MSE will change the Memorandum of Understanding to parallel Beedie's FIC Pre-MBA program and remove the reduction in the academic admission standard.

Based on the discussion, W. Parkhouse proposed the following motion:

That SGSC approve the conditional admission of students that do not meet the normal English Language Requirements but have minimally an IELTS 6.5 or equivalent, to the MEng in Product Realization provided they successfully complete the MSE-FIC Pre-Master's program on a two year trial basis.

SGSC discussed that some course changes are dramatic enough that creating a new course is necessary. CRIM 810, CRIM 811, CRIM 830 and CRIM 831 appear that their changes are substantial enough to warrant the creation of new courses. M. Andresen explained that the changes merely reflect what has been taught in those courses for multiple offerings. SGSC suggested a further rationale is provided to explain the changes.

SGSC was informed that CRIM 740, CRIM 742 and CRIM 815 have had their overlap issues resolved.

f) Program proposal: Terrorism, Risk, and Security Studies Professional Master's Program (Cohort Special Arrangement)

SGSC requested a clarification to the definitions of terrorism and risk in the program description to demonstrate that is a broader definition which will be able to keep up with the contemporary global issues.

SGSC also requested clarity on the role of the advisory committee for this program; in particular what is the member's involvement in designing the program.

A question was raised about supervisory capacity for this new program and how many students the program will anticipate in the first year. M. Andresen responded that they expect to have 8 - 10 students and that many individuals have been identified as potential readers for the project. It was unclear in the proposal if the project was to be submitted to the university repository. SGSC requested this be confirmed.

Concern was raised on how this will impact submitting to subscription based journals. SGSC was informed that many subscription based journals will still allow the author to submit their work to institutional repositories in addition to the journals.

SGSC enquired about enforcing compliance. N. White offered possible options that have been considered including an internal audit sent to senate. She asked SGSC members to send her any comments and concerns related to this policy which will be discussed at a future meeting.
