5.1 Faculty of Arts and Social Sciences

Department of Psychology

5.1.1 Full program proposal: Terrorism, Risk, and Security Studies (TRSS) MA

S. Hart attended this portion of the meeting to introduce the proposal and answer questions, B. Basi attended this portion of the meeting as an observer on behalf of SCUP.

SGSC inquired about the number of applications, maximum cohort size, and how the program will be advertised. SGSC was informed that on average the program receives 35 applications with roughly 50% acceptance rate. The plan is to increase intake numbers to at least 25 students per cohort. Currently, the program is advertised only through word of mouth and faculty attending conferences; therefore, minimal effort will be required to raise its profile. S. Hart ensured the committee that there is an adequate number of faculty available to teach and supervise students. B. Basi recommended adding external letters of support and providing evidence that consultations with other institutions with similar programs took place. It was recommended only including one CIP code in the proposal that is most common to all other institutions. A committee member requested not starting spring 2021 admissions until the

Ministry has approved the program. Minor language revisions were recommended throughout the proposal.
