5.1 2019 Annual Report of SGSC

5.2 Faculty of Applied Science

5.2.1 Program Change: Computing Science MSc and PhD

As the program only offers direct admission into the thesis stream, it was requested that the following sentence be added to the admission requirements section: "Direct admission is only permitted into the Thesis option".

The committee was informed that students who completed CMPT 700 in their MSc program, will not be required to repeat it in the PhD program. It was recommended that the language regarding this be added to the calendar entry.

It was requested that the language for MSc and PhD be modified under "Transfer from MSc to PhD Program" to reference the appropriate GGR number.

5.2.2 New Course: CMPT 700 Technical Writing & Research

The course title doesn't closely reflect course curriculum. It was requested to change the title to "Technical Writing and Research Communication".
