The committee was previously informed of the discontinuation of the Cohort Special Arrangement program (CSAR) at SFU. The Ministry requests all new programs go through the full program proposal approval process. The removal of the GGR ensures policy is aligned with the request from the Ministry.

Several committee members expressed concerns about the impact of discontinuing CSAR and whether there are options to test run programs before developing a full proposal. It was

explained there are ways to work within existing programs to test curriculum without making significant changes that require Ministry approval.

### 6. For Discussion

SGSC discussed how TA positions are being affected by international travel restrictions due to the global pandemic. Payment for TA work and other funding can be applied to student accounts to cover tuition and fees, but funds cannot be deposited into international bank accounts due to legal restrictions. Future guidance from the federal government may help manage these challenges and support international students.

Further discussion took place regarding the other challenges faced by international students during COVID-19. Concerns were raised on students obtaining study permits, future travel options and quarantine guidelines. The committee was reminded that International Services for Students (ISS) has registered Canadian Immigration Consultants and can provide the most up to date and accurate information to assist international students. GPS is also looking at different ways to work with ISS to support graduate international students.

A committee member asked if there would be additional support provided to faculty and students to improve the online learning experience. The committee was informed the Center for Educational Excellence has put together extensive resources for faculty, staff and students addressing remote learning. Supervisors can also consult with J. Derksen and G. Agnes for guidance on supervising remotely.

A committee member asked about admissions deposits for Fall. The committee was informed departments have the authority to decide on admissions deposits and if refunds will be issued. It was also noted the option exists for students to delay paying the deposit until they are ready to enroll in courses.

K.Gerlich-Fitzgerald announced the new payment plan for students had been launched which would provide additional options during this time allowing students to pay tuition in installments.

G. Agnes brought forward that documents for thesis submission are being reviewed and consolidated to simplify the process. Discussion took place regarding the signatures of Associate Deans on these forms.
