The chair communicated that if the Federal Government receives the applications by May 15, 2021, the student will receive their study permit by August 6 and thus will have time to travel to Canada for the fall term. This commitment may not be consistent for those students coming from India and Pakistan. Currently, SFU has 108 students from the two countries. It is likely that the academic unit most impacted will be the School of Computing Science.

P. Saeedi agreed that 47% of their students are currently affected.

The chair provided statistics from SFU IRP that the summer 2021 headcount for enrollment is up 13% from the spring 2021 term. The Chair commented that although there was an increase of applications by 40%, there is no certain indication that fall 2021 will have growth, as SFU does not know if it will be safe for students from India and Pakistan to travel to Canada by then.

SGSC discussed applications and enrollment for fall 2021 in various academic units. Overall, the numbers were either consistent or slightly lower compared to the previous year. A. Gemino informed the committee that the number of international and domestic students enrolled is slightly higher this year. M. Silverman expressed concern regarding grant funding and that it will be a huge factor in determining the students they can admit to their faculty.

The chair recommended that graduate departments should prepare for more students to study in-person than remote. The Chair discussed SFU's two plans and an announcement will be made by May 28, 2021. If it isn't safe for students to be on-campus there are plans for remote or blended learning.

A. Gemino commented that if international Business students are unable to obtain travel visas, 50% of them would be remote.

It was explained that Canadian government can't force its citizens to get vaccinated and that some of the international students may not have access to the vaccine in their home countries. The chair advised that the decision not to inquire about vaccination is based on an inquiry made to the Freedom of Information policies of the Canadian government. A committee member inquired whether the university is able to receive feedback from the government regarding this issue. The chair explained that SFU holds regular dialogue with the Provincial Health Authority. The chair informed SGSC that the committee's concerns will be brought up to the planning committee.
