The committee discussed the different pathways of entry, and the flexibility of the program to collaborate with Indigenous leaders and communities. A committee member asked about resources for students completing the project option using multimedia. These projects would be more dependent of grants and supervisorial funding.

The committee also raised concerns around the structure for administrative oversight. A GPC should have final approval for matters related to admissions, funding, and administration. Under the proposed structure, authority is placed entirely on a separate committee. It was clarified because the program is situated within the Department of Linguistics, further consideration is needed regarding the relationship of the program committee and the Linguistics GPC.

It was also requested the proposed credential be updated to "Master of Arts" unless the intention was to create a new credential type.

K. Gerlich-Fitzgerald updated SGSC that graduate students will have the opportunity to be speakers at the June virtual convocation. Faculties will be asked to nominate potential speakers to provide a two minute pre-recorded message.

SGSC discussed the leave options for graduate students. It was clarified the conditions for an academic break cannot be modified; this category of leave follows guidelines required by Immigration, Refugees and Citizenship Canada. The committee discussed student concerns regarding the impact of terms on leave displayed on transcripts. Transcripts do not specify the type of leave, but if requested this information can be acquired.

A committee member asked about graduate students leaving the country without notifying their program or supervisor. It was noted the main concern would be if these students are receiving grant funding with a residency requirement. Otherwise, students are not required to notify their programs. Academic units should continue to follow the policy outlined under GGR 1.8 if there are concerns about progress. SGSC was reminded students should complete the Graduate Progress Report at least once a year, but a committee could request this report be completed more often.
